<u>Crédit Agricole Assurances and Crédit Agricole Immobilier team up</u> <u>to develop low-carbon office buildings</u>





19 April 2021 – Crédit Agricole Immobilier is pleased to announce that it will be partnering Pacifica, Crédit Agricole Assurances' non-life insurance subsidiary, to develop low-carbon buildings that will be used for claims management operations. This is part of a responsible approach to real estate to reduce energy consumption and protect the environment.

The main goal of this five-year renewable partnership is to develop buildings to house Pacifica's claims management operations by identifying land with considerable appeal and building a number of structures that are geared towards energy conservation and energy efficiency. The focus will be on wood-framed structures, biosourced insulation materials (e.g. wood wool), connections to urban heat networks, natural light and the reuse of recovered building materials (e.g. in raised floors).

Six French cities have been pinpointed for the first of these low-carbon office buildings: **Caen, Dijon, Grenoble, Saint Etienne, La Roche-sur-Yon and Montpellier.** By 2022, each one will welcome a claims management unit spanning a floor area of approximately 1,800 sq.m. spread over two levels, with outdoor parking and elegantly-designed high-tech, comfortable workspaces.

By 2026, 20 such office buildings are expected to be built to the highest industry standards, securing **HQE** "Excellent" certification and the **BBCA** (Bâtiment Bas Carbone), E+C- (E3/C2) and BiodiverCity® labels, in preparation for the introduction of France's RE 2020 environmental regulation. For every square metre built, these claims management units will leave a carbon footprint that will be 2.5 times lower than conventional new buildings.

"This partnership is a core component of our strategy and underpins our role as a responsible insurer that is committed to the energy transition. By capitalising on intra-group synergies, we are pursuing our efforts to address major climate change issues and meet the expectations of our customers and staff. This partnership furthers the societal aspect of the Crédit Agricole Group's CSR strategy, by positioning Crédit Agricole Assurances as a socially-responsible company that is working to reduce the direct impact of its operations on the environment", comments **Thierry Langreney**, Deputy Chief Executive Officer of Crédit Agricole Assurances and Chief Executive Officer of Pacifica.





For Crédit Agricole Immobilier, this partnership is part of an overarching strategy to reduce the carbon footprint of buildings, in keeping with the "eco-building" aspect of its CSR policy. "As a responsible real estate developer, we have a duty to lay the groundwork for a transition to a more responsible society, by developing properties that help counter climate change. Today, we are proud to be able to offer responsible buildings that can be adapted to small commercial structures, meeting the needs of our customers and enhancing the appeal of regional locations", comments Marc Oppenheim, Chief Executive Officer of Crédit Agricole Immobilier.
